

## Terms of electronic invoicing

For purpose of acceptance of electronic invoice in companies, which are part of the Hedin Automotive, the conditions below must be fulfilled.

If any of the following conditions are not fulfilled, the electronic invoice is considered as not delivered.

1. In accordance with § 71 par. 1 letter b) Act no. 222/2004 Coll. on value added VAT law, an electronic invoice is tax document.
2. The electronic invoice is a full-fledged substitute for paper form invoice and therefore the supplier is no longer obliged to send invoices in paper form to the Customer / Customer.
3. The electronic invoice is considered delivered on the day of receipt of the confirmation of delivery of the electronic invoice by the Customer / Customer of the Suppliers.
4. The Supplier is obliged to request for automatic email confirmation about the delivery of an electronic invoice from the Customer / Subscriber. If the Supplier does not receive a confirmation of delivery of the invoice to the Customer / Subscriber, the Supplier is obliged to make another attempt to electronically send the invoice to the Customer / Subscriber. If the another attempt to electronic delivery of the invoice to the counterparty is not successful, the Supplier will send the invoice in paper form.
5. The customer undertakes to inform the Supplier of various changes affecting the sending of electronic invoices, in particular the change of the contact e-mail for sending electronic invoices.
6. The Customer confirms that he has exclusive access to the contact email for sending electronic invoices. The Supplier is not responsible for damages caused by the leakage of data from the mailbox assigned to the Customer's e-mail address.
